



## TUITION & PAYMENT OPTIONS

### Enrollment & Re-enrollment Fees

Current LCA families have priority enrollment until March 1. The enrollment/re-enrollment process is not considered complete without a payment plan set-up through FACTS:

- **New Enrollment:** \$100 per student (max. \$200 per family)
- **Re-enrollment:**
  - If enrolled by March 31 - Free
  - If enrolled from April 1-April 30 - \$200 per child
  - If enrolled from May 1-May 31 - \$300 per child
  - If enrolled after May 31 - \$350 per child

### Payment Plan Options

1. Pay in full by March 1, 2019 - 3% discount
  - Discount applied after multi-child discount.
  - Not eligible if receiving tuition assistance.
  - Discount will be reversed in the event of early withdrawal.
2. Pay in full from March 2- April 1, 2019 - 2% discount
  - Discount applied after multi-child discount.
  - Not eligible if receiving tuition assistance.
  - Discount will be reversed in the event of early withdrawal.
3. Automatic Quarterly Payments
  - Payment dates are June 5, September 5, December 5 (2019) and March 5 (2020).
4. Automatic Ten (June 2019-March 2020) or Twelve Monthly Payments (June 2019-May 2020)
  - Payment dates are the 5<sup>th</sup> or 20<sup>th</sup> of each month.

### FACTS Tuition Management

All tuition agreements for your payment plan and payments for tuition/fees are made through FACTS (<https://onlinefactsmgt.com/signin/3CXTN>). There is either a \$20 or \$46 one-time per year processing fee based on the payment option. All families are required to enroll in FACTS Tuition Management.

## New Student Referral Incentive (\$300)

A \$300 incentive will be awarded to a current LCA family for the referral of each new student. The \$300 will be applied to the family's tuition or paid to the family directly. Incentives will be applied once the new student has completed two quarters at LCA. PreK 1/2 day, 2-day, and 3-day referrals will be prorated.

## Additional Fees

Additional fees may be incurred throughout the school year depending upon the student's involvement in specific classes, sports, or other activities.

### Sports Fee

9<sup>th</sup>-12<sup>th</sup> Grade: \$175 per sport season\*

\*There is an additional fee for hockey of \$350 and for golf of \$150.

5<sup>th</sup>-8<sup>th</sup> Grade: \$150 per sport season\*

Outgoing transfer students playing sports at Legacy per MSHSL rules: An additional \$1,000 per sport season

### Drama Fee

9<sup>th</sup>-12<sup>th</sup> Grade: \$150 (Spring production only)

5<sup>th</sup>-8<sup>th</sup> Grade: \$125 (Spring production only)

### Graduation Fee

12<sup>th</sup> Grade (one-time): \$100

### After Care Fee (PreK fees are automatically added to payment plan unless otherwise specified)

PreK 2-Day: \$350/year

PreK 3-Day: \$450/year

PreK 5-Day: \$750/year

Kindergarten-4<sup>th</sup> Grade: \$5/hour (billed bi-weekly)

## Multi-Child Scholarship

Multi-child scholarships are automatically credited to your tuition unless your family qualifies for tuition assistance.

2 students per family | \$200/student

3 students per family | \$300/student

4+ students per family | \$400/student

Not available if accepting tuition assistance

Prorated discount for PreK 1/2 day, 2-day, and 3-day

## Tuition Assistance

Families applying for tuition assistance must complete an online application form, pay a \$35 application fee, and submit necessary supporting documentation to FACTS Grant & Aid Assessment via [www.onlinefactsmgt.com/aid](http://www.onlinefactsmgt.com/aid). Assistance requests will be prioritized by the date received, and processed on the 15<sup>th</sup> and 30<sup>th</sup> of each month. **Tuition assistance applications that are received after May 1 may result in a lower granted amount due to the tuition assistance available.** The tuition assistance application process requires completion of your federal taxes from the prior year. New families are asked to submit tuition assistance applications within 15 days of acceptance to LCA.

\*The PreK 1-day and 2-day programs do not qualify for tuition assistance.

## Withdrawal Penalties/Tuition Refunds

Withdrawal penalties and tuition refunds will be applied per student according to the following schedule:

Student withdraws between June 1 and August 19, 2019 | \$750

Student withdraws between August 20 and September 30, 2019 | \$750 plus prorated tuition\*

Student withdraws between October 1 and October 31, 2019 | \$500 plus prorated tuition\*

Student withdraws between November 1, 2019 and May 31, 2020 | \$400 plus prorated tuition\*

\*Tuition is prorated to the last day of the month of withdrawal.

## Past Due Balances/NSF Fee

A student that has a tuition balance more than 60 days past due may not be allowed to attend classes until the account is made current. Any student with a balance still remaining on June 30 will not be allowed to re-enroll until the balance is paid in full or a satisfactory payment arrangement is agreed upon. A non-sufficient funds (NSF) fee of \$30 will be assessed for any payment returned by our bank.

## State & Federal Subsidy Programs

Under current legislation, parents may claim a credit and/or deduction on their Minnesota State Income Tax return for some K-12 education expenses. The amount of the credit/deduction depends upon family income. The Legacy PreK program is licensed through the Department of Human Services. Tuition paid for PreK may qualify as a deduction on your federal and/or state tax return. Please contact a tax professional for further information.
