

Return to School Notice and Release

Legacy Christian Academy is hereby providing notice to me/us that it currently intends to open its educational and school program for the 2020-21 school year. I/we understand that Legacy cannot protect my child(ren) and/or me from risks, which may be encountered as a result of my child(ren) attending Legacy. I/we realize there are natural, mechanical, and environmental conditions and hazards which independently or in combination with any activities engaged in while participating in this program may result in the exposure to certain risks including exposure to coronavirus (COVID-19), or other biological agents, virus, or similar bacteriological agents, and the risk of being quarantined, or illness that may result in medical care, hospitalization, or death.

I/we hereby state that I/we, on behalf of my/our child(ren) and myself, am an adult, over the age of 18, and legally competent to sign this form. I/we understand these inherent risks and dangers involved with participation in the school providing its educational program and acknowledge the existence of risks which are not obvious or predictable, and hereby intend this release to extend to injury or loss which results from both obvious or predictable risks, as well as risks that are unpredictable and not obvious, and to extend to myself and my child(ren), as applicable.

In consideration of myself and my/our child(ren) participating in Legacy's educational and school program, I/we, and any legal representatives, heirs and assigns, hereby release, waive, and indemnify Legacy Christian Academy, its officers, directors, employees, agents, and representatives from any and all liability for any and all loss or damage, and any claim or damages resulting therefrom, on account of any injury, illness, or exposure to and/or contracting the coronavirus (COVID-19) or other biological agents, virus, or similar bacteriological agent by me or my/our child(ren)'s attendance at and participation in Legacy Christian Academy's educational program, including any medical expenses, injury, and/or death.

I/we have carefully read the foregoing release and know and understand the contents thereof. I/we sign this release voluntarily as my/our own free act with full knowledge of its significance, intending to be legally bound thereby.

Each parent or guardian that has custody of a Legacy child must return this agreement by August 24. Legacy must have a signed Notice & Release for every student before they begin attending their 2020-21 classes.
