Enrollment & Re-enrollment Fees

Current Legacy families have priority enrollment until January 31, 2024. Enrollment opens to the public on February 7, 2024. The enrollment/re-enrollment process is not considered complete without a payment plan set up through FACTS.

New Enrollment: \$100 per student (max. \$200 per family)

Re-enrollment:

- If enrolled by January 31 | Free
- If enrolled from February 1-March 31 | \$200 per child
- If enrolled from April 1-April 30 | \$300 per child
- If enrolled after April 30 | \$350 per child

Payment Plan Options

1. Pay in full by April 1, 2024 | 2% discount
 - Discount applied after multi-child discount.
 - Not eligible if receiving tuition assistance.
 - Discount will be reversed in the event of early withdrawal.
2. Automatic Quarterly Payments
 - Payment dates are June 5, September 5, December 5 (2024) and March 5 (2025).
3. Automatic Ten (June 2024-March 2025) or Twelve Monthly Payments (June 2024-May 2025)
 - Payment dates are the 5th or 20th of each month.

Please note: If you choose to use a credit card to pay tuition at Legacy, a 4% processing fee will be assessed.

FACTS Tuition Management

All tuition agreements for your payment plan and payments for tuition/fees are made through FACTS. FACTS charges either a \$25 or \$55 one-time per year processing fee based on the payment option chosen. All families are required to enroll in FACTS Tuition Management.

Multi-Child Scholarship

Multi-child scholarships are automatically credited to your tuition unless your family qualifies for tuition assistance.

- 2 students per family | \$200/student *Not available if accepting tuition assistance*
- 3 students per family | \$300/student *Prorated discount for PreK Half-Day, 2-Day, and 3-Day*
- 4+ students per family | \$400/student

Additional Fees

Additional fees may be incurred throughout the school year depending upon the student's involvement in specific classes, sports, or other activities.

After Care Fee | PreK-4th Grade: \$6/hour (billed bi-weekly)

Drama (5-12) | \$250 per season

Robotics (9-12) | \$250

Sports (5-8) | \$250 per sport season

Sports (9-12) | \$275 per sport season*

**Outgoing transfer students choosing to play at Legacy per MSHSL bylaws pay an additional \$1,000 per sport per season.*

Tuition Assistance

Because tuition assistance is a scholarship and the funds are budgeted, the earlier you apply, the more funds are available. We have some very generous donors who help make some of these funds available, but there is a limited amount. The tuition assistance process requires completion of your federal taxes. Because our deadline is early, you may use the previous year's taxes to apply. *Please note, the Half-Day Preschool and all day, 2-Day PreK classes do not qualify for tuition assistance.*

Current Families: Families applying for tuition assistance must complete the online application, pay a \$40 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via online.factsmgt.com/aid. Tuition assistance applications are due by **February 15** and aid will be awarded in March.

Due to budgeting and planning purposes, awards will be decreased by \$250/child for any applications received after February 15. Late submissions will also result in delayed awards.

New Families: New families applying for tuition assistance must complete an online application, pay a \$40 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via online.factsmgt.com/aid **within 15 days of acceptance** to Legacy. Failure to do so may result in lower aid awarded.

Withdrawal and Related Tuition Payments

Enrollment for the next enrollment year will occur automatically and families will be responsible for tuition according to the schedule below, unless written notification of cancellation/withdrawal is received by the school prior to March 15.

- Student withdraws between March 15 and May 31, tuition for enrollment year will be charged at 10% of contract amount.
- Student withdraws June 1 or later, 20% of contract amount plus prorated tuition* (not to exceed 100% of contract amount).

* **Tuition is prorated to the last day of the month of withdrawal.**

The above schedule is effective whether the withdrawal is for expulsion, dismissal, transfer, or otherwise. Under any withdrawal circumstance, the registration deposit is non-refundable and will not be pro-rated.

Past Due Balances/NSF Fee

A student that has a tuition balance more than 60 days past due may not be allowed to attend classes until the account is made current. Any student with a balance still remaining on June 30 will be administratively withdrawn from enrollment until the balance is paid in full or a satisfactory payment arrangement is agreed upon. A non-sufficient funds (NSF) fee of \$30 will be assessed for any payment returned by our bank.

Tax Credit and/or Deduction Opportunities

Under current legislation, parents may claim a credit and/or deduction on their Minnesota State Income Tax return for some K-12 education expenses. The amount of the credit/deduction depends upon family income. The Legacy PreK program is licensed through the Department of Human Services. Tuition paid for PreK may qualify as a deduction on your federal and/or state tax return. Please contact a tax professional for further information.

Continuous Enrollment

Your child(ren) will be automatically re-enrolled at Legacy each school year until their graduation from Legacy (unless they are withdrawn). The enrollment agreement current families receive this January and need to complete will include provisions to adopt continuous enrollment for the following years.

Ongoing Tuition and Fees

The tuition and fee amounts detailed in this document are for the 2024-2025 school year. Each enrollment year, Legacy may change the tuition and fee amounts described herein at its sole discretion, and will notify families of any changes annually.
