### Continuous Enrollment

Because we value our families, Legacy adopted continuous enrollment! This will save time because there are no forms to fill out year after year\*! Once a student is enrolled, they are considered part of the Legacy family for the duration of their education. Because continuous enrollment is now the default, all current payment plans will continue unless the Business Office is notified with any necessary changes or a family withdraws.

Enrollment for the next school year will occur automatically, and families will be responsible for tuition according to the tuition chart above, unless written notification of cancellation/withdrawal is received by the school prior to the deadlines listed below.

In the unlikely event that a family wishes to withdraw/cancel their enrollment, they are required to complete an enrollment cancellation form and submit it to the Admissions Office. **Current Legacy families may withdraw, free of charge, until January 31, 2025 after which time the following fees are in effect:**

- Until January 31: No charge
- February 1–March 31: tuition for enrollment year will be charged at 10% of contract amount per student
- April 1–July 14: tuition for enrollment year will be charged at 20% of contract amount per student
- July 15 or later: tuition for enrollment year will be charged at 30% plus tuition prorated to the last day of the month of withdrawal (*not to exceed 100% of the contract amount*)

The tuition contract is in effect whether the withdrawal is for expulsion, dismissal, transfer, or otherwise. Under any withdrawal circumstances, the registration deposit is non-refundable and will not be prorated.

*\*It is your responsibility to update Legacy with any health, demographic, or pertinent information regarding your child. Please contact the School Office at 763.427.4595 with any changes.*

### Payment Plan Options

1. Pay in full by April 1, 2025 | 2% discount
  - Discount applied after multi-child discount.
  - Not eligible if receiving tuition assistance.
  - Discount will be reversed in the event of early withdrawal.
2. Automatic Quarterly Payments
  - Payment dates are June 5, September 5, December 5 (2025) and March 5 (2026).
3. Automatic Ten (June 2025–March 2026) or Twelve Monthly Payments (June 2025–May 2026)
  - Payment dates are the 5<sup>th</sup> or 20<sup>th</sup> of each month.

Please note: If you choose to use a credit card to pay tuition at Legacy, a 4% processing fee will be assessed.

## FACTS Tuition Management

All tuition agreements for your payment plan and payments for tuition/fees are made through FACTS. FACTS charges either a \$25 or \$55 one-time per year processing fee based on the payment option chosen. All families are required to enroll in FACTS Tuition Management. *Please note: There is a \$100 enrollment fee per student (max. \$200 per family).*

## Multi-Child Discount

Multi-child discounts are automatically credited to your tuition unless your family qualifies for tuition assistance.

- 2 students per family | \$200/student Not available if accepting tuition assistance
- 3 students per family | \$300/student Prorated discount for PreK Half-Day, 2-Day, and 3-Day
- 4+ students per family | \$400/student

## Additional Fees

Additional fees may be incurred throughout the school year depending upon the student's involvement in specific classes, sports, or other activities.

- After Care Fee | PreK-4<sup>th</sup> Grade: \$6/hour (billed bi-weekly)
- Drama (5-12) | \$250 per season
- Robotics (9-12) | \$250
- Sports (5-8) | \$250 per sport season
- Sports (9-12) | \$275 per sport season\*

\*Outgoing transfer students choosing to play at Legacy per MSHSL bylaws pay an additional \$1,000 per sport per season.

## Tuition Assistance

Because tuition assistance is a scholarship and the funds are budgeted, the earlier you apply, the more funds are available. We have some very generous donors who help make some of these funds available, but there is a limited amount. The tuition assistance process requires completion of your federal taxes. **Because our deadline is early, you may use the previous year's taxes to apply.** *Please note, the Half-Day Preschool and all day, 2-Day PreK classes do not qualify for tuition assistance.*

**Current Families:** Families applying for tuition assistance must complete the online application, pay a \$45 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via [online.factsmgt.com/aid](https://online.factsmgt.com/aid). Tuition assistance applications are due by February 15 and aid will be awarded in March. Due to budgeting, planning purposes, and limited financial aid, awards will likely decrease for any applications received after February 15. Late submissions will also result in delayed awards.

**New Families:** New families applying for tuition assistance must complete an online application, pay a \$45 tuition assistance application fee, and submit all necessary documentation to FACTS Grant and Aid Assessment via [online.factsmgt.com/aid](https://online.factsmgt.com/aid) within 15 days of acceptance to Legacy. Failure to do so may result in lower aid awarded.

## Past Due Balances/NSF Fee

A student that has a tuition balance more than 60 days past due may not be allowed to attend classes until the account is made current. Any student with a balance still remaining on June 30 will be automatically disenrolled and will not be allowed to re-enroll until the balance is paid in full or a satisfactory payment arrangement is agreed upon. A non-sufficient funds (NSF) fee of \$30 will be assessed for any payment returned by our bank.

## Tax Credit and/or Deduction Opportunities

Under current legislation, parents may claim a credit and/or deduction on their Minnesota State Income Tax return for some K-12 education expenses. The amount of the credit/deduction depends upon family income. The Legacy PreK program is licensed through the Department of Human Services. Tuition paid for PreK may qualify as a deduction on your federal and/or state tax return. Please contact a tax professional for further information.

## Ongoing Tuition and Fees

The tuition and fee amounts detailed in this document are for the 2025-2026 school year. Each enrollment year, Legacy may change the tuition and fee amounts described herein at its sole discretion, and will notify families of any changes annually.
